### HUNNAR SE ROZGAR TAK

Skill Development, for the purpose of any Government scheme, is defined as any domain specific demand led skill training activity leading to employment or any outcome oriented activity that enables a participant to acquire a skill duly assessed and certified by an independent third party agency, and which enables him/her to get wage/self-employment leading to increased earnings, and/or improved working conditions, such as getting formal certification for hitherto informal skills, and/or moving from informal to formal sector jobs or pursue higher education/training.

The Hunar Se Rozgar Tak scheme is for upskilling / reskilling and has assumed significance for social upliftment and employment of our youth. The scheme has been expanded to encompass different segments of the hospitality sector with predetermined objectives.

Ministry of Tourism implemented Hunar Se Rozgar program through Hotel Management affiliated to NCHMCT. Programmes are supported and sponsored by MOT.

After incorporating the Common Norms as notified by the Ministry of Skill Development & Entrepreneurship, as revised from time to time, the revised Guidelines governing the implementation of the “HUNAR SE ROZGAR TAK” programme of the Ministry of Tourism would be as follows with immediate effect:-

#### **Important Instructions:**

1. **Admission Criteria:** On **first come first serve basis** (Date of submission of Admission Form)
2. **Application Fee:** There will be **no application or course fees chargeable to applicants.**
3. **Age:** Age limit is 18 to 28 years as on 01.01.2022
4. Training program will be started on attaining a minimum strength of 25 to begin with. Registered candidate will be informed 1 week before the commencement of the training.
5. HSRT candidates will be provided with prescribed uniform, tool kit and course material.
6. The candidate will be granted a stipend upon successful completion of the course with minimum 80% attendance and successfully qualifying the Course End Test.
